## HUD 2009 Continuum of Care Homeless Assistance Programs NOFA

In the October 1, 2009 edition of the *Federal Register*, HUD announced \$1.43 billion in competitive homeless assistance funds. The application deadline is November 9, 2009.

Applicants may obtain copies of HUD's FY2009 CoC NOFA and the HUD's Fiscal Year 2009 Notice of Funding Availability (NOFA) Policy Requirements and General Section to HUD's FY2009 NOFAs for Discretionary Programs (General Section) at [www.hud.gov/offices/adm/grants/fundsavail.cfm](http://www.hud.gov/offices/adm/grants/fundsavail.cfm). The full text of the program funding notice may be found at [www.hudhre.info/documents/FY2009CoCNOFA.pdf](http://www.hudhre.info/documents/FY2009CoCNOFA.pdf).

Applicants will be required to complete and submit their applications in e-snaps at [www.hud.gov/esnaps](http://www.hud.gov/esnaps). This system is not part of Grants.gov. Applicants are strongly encouraged to carefully review application submission requirements contained in the FY2009 CoC NOFA. The Catalogue of Federal Domestic Assistance (CFDA) numbers for the CoC Homeless Assistance Program are: 14.235, Supportive Housing Program (SHP); 14.238, Shelter Plus Care (S+C) and 14.249, Section 8 Moderate Rehabilitation Single Room Occupancy (SRO).

### 2009 CoC NOFA and Application Broadcast

On Friday, September 25, HUD delivered a live Webcast on the 2009 Continuum of Care (CoC) Notice of Funding Availability (NOFA). The Webcast includes information on the 2009 CoC NOFA and the e-snaps application process. Programs covered by the NOFA are the Supportive Housing Program, Shelter Plus Care, and the Section 8 Moderate Rehabilitation for Single Room Occupancy program.
